Minocqua Police Activity Report December, 2017

Incidents:

During the month of December, 2017, the Minocqua Police Department handled 367 incidents with an additional 396 calls for service from the public which involved dispatching Woodruff Police Department, fire and EMS. The 367 incidents also include calls self-initiated by officers of the Department. A breakdown of those calls in comparison to past years is as follows:
