# Minocqua Police Activity Report July, 2017

### Incidents:

During the month of July, 2017, the Minocqua Police Department handled 641 incidents with an additional 480 calls for service from the public which involved dispatching Woodruff Police Department, fire and EMS. The 641 incidents also include calls self-initiated by officers of the Department. A breakdown of those calls in comparison to past years is as follows:
